

MUNICIPALITY OF GRASSLAND

BY-LAW No. 2024-01

BEING A BY-LAW TO provide for and authorize the remuneration of and payment of certain expenses to members of council and council committees.

WHEREAS The Municipal Act states in part that as follows:

124(2) A council may by by-law set the types, rates and conditions of payments to be made to or on behalf of members of the council and council committees, other than the committee of a local urban district,

- (a) as compensation for attending to municipal business
- (b) for expenses incurred while attending to municipal business; and
- (c) for any other purpose relating to municipal business that the council considers appropriate.

AND WHEREAS it is deemed expedient and in the best interest of the Municipality of Grassland to provide payment of indemnities and expenses to each member of council;

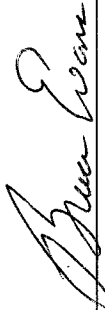
NOW THEREFORE be it enacted as a by-law of the Municipality of Grassland as follows:

1. The total annual compensation for the Reeve shall be \$10,000.00 and shall be paid as follows:
 - (a) Quarterly payments of \$2,500.00 paid as an indemnity subject to income tax.
2. The total annual compensation for each Councillor shall be \$7,500.00 and shall be paid as follows:
 - (a) Quarterly payment of \$1,875.00 paid as an indemnity subject to income tax.
3. THAT the Reeve and each member of Council may be paid actual travelling expenses at a rate of \$0.59 per kilometer for each kilometer actually and necessarily travelled in the performance of duties, work or service authorized.
4. THAT the Reeve and each member of Council may be paid \$20.00 per hour for each hour actually and necessarily spent in performance of such duties, attending special meetings of council, work, or service as is required or authorized to perform under a by-law or resolution meetings, subject to income tax.
5. THAT each member of Council has authorization to attend the annual conventions of the Association of Manitoba Municipalities (AMM), AMM District Meetings, Municipal Officials meetings and seminars, and shall be paid
 - (a) The actual travelling expenses and actual living expenses; and
 - (b) The maximum rooms at the annual A.M.M Convention
 - i. Brandon – 3 nights
 - ii. Winnipeg – 4 nights
 - (c) \$160.00 per day for days actually attended at the annual A.M.M. Convention
6. THAT the Reeve and each member of Council, when travelling beyond the limits of the municipality on the business of Council, shall be paid:
 - (a) Actual living expenses
 - (b) Actual traveling expenses
 - (c) A meal allowance of \$50.00 per day (receipts not required)
 - (d) An indemnity as follows:
 - i. The sum of \$160.00 per day (8 hours) or \$80.00 per half day (4 hours), subject to income tax.

REPEAL

9.0 By-Law No. 3-2015 is hereby repealed.
